This tender is governed by the special business terms and condition, which are published in the implementation documentation of this tender.

In order to be able to participate in this tender, the Candidate is required to conclude a Deposit Agreement within the first round. The Deposit Agreement must be concluded in writing and the signature on the Deposit Agreement must be officially verified due to czech law. This is available to those interested in the system after registration - Deposit Agreement.pdf. Applicants who meet the conditions of the 1st round are admitted to the 2nd round. In the 2nd round, the interested parties submit their proposal in a sealed envelope marked "COOLING TOWERS PRAGUE - SALE OF THE SET OF EQUIPMENT - DO NOT OPEN."

Immediately after the second round, the value of the highest bid from the second round is published. The final bid in the 3rd round is submitted by candidates whose bid in the 2nd round was placed in the first or second or third place (these candidates will be immediately informed by e-mail or telephone). The third round will take the form of submission of envelopes in the same way as in the second round, except that the Seller may set a minimum amount of new bids ("Increased bids"), or the third round will take place in the form of an English auction ("Final Auction").

Immediately after the evaluation of the 3rd round, the highest proposal from the third round is published (= final highest bid).

These structures are in good condition, and the structures of the runways and footbridges are de facto ready for further use on the construction site.

The components of the masts that were intended for outdoor storage are in good condition and 90% of them can be used immediately for the assembly of masts.

The device also includes sheet metal formwork. It consists of formwork boards of different widths (600-3 types, 570, 450, 300, 150). Due to the absence of handling equipment, the inventory was performed by estimating the quantity based on the number of boards in the transport pallet and the number of pallets. The calculation was performed independently three times. The plates were stored in the following quantities:

The test bench consists of two basic parts of a lattice structure made of hot-dip galvanized profiles for the assembly of clamping and testing of masts under the. The test bench includes clamping elements, hydraulic unit, dynamometer HOTTINGER BALDWIN MESSTECHNIK, type U10M / 50 kN, two electrical switchboards, control panel and last but not least a computer with a program for controlling the load hydraulic unit, evaluation of the total load and deformation of the tested tower. The test bench was found to be missing a computer with test software. To test each mast, it will be necessary to secure these missing components, without which the test bench will be unusable.

The test polygon is specially designed for the preparation and training of workers before their involvement in the activities on the Set of equipment for drawing the cooling tower casings with natural draft of the company Chladicí věž Praha, a.s.





